Pursuant to Article 16 and 61 (2) of the Law on Administration (Official Gazette of BIH 32/02 and 102/09) and Article 13 (1) e) of the Aviation Law of Bosnia and Herzegovina (Official Gazette of BIH 39/09), with the prior approval of the Council of Ministers of Bosnia and Herzegovina, the Director General of the Bosnia and Herzegovina Directorate of Civil Aviation hereby issues

#### DECISION

#### ON THE AMOUNTS OF FEES FOR THE SERVICES PROVIDED WITHIN THE SCOPE OF RESPONSIBILITY OF THE BOSNIA AND HERZEGOVINA DIRECTORATE OF CIVIL AVIATION

#### PART I - GENERAL PROVISIONS

Article 1

(Subject matter)

This Decision lays down the amounts of the fees collected by the Bosnia and Herzegovina Directorate of Civil Aviation (hereinafter: BHDCA) from the revenues collected within its scope of business in regard to the following activities: oversight, compliance checks for issuance of certificates, authorisations and approvals, in the fields of airworthiness and aircraft operations, flight crew licensing, aviation security, air navigation and aerodromes.

### PART II – FEES IN THE FIELD OF AIRCRAFT AIRWORTHINESS

#### Article 2

(2) The fee for a regular check of the requirements in an airport certificate (for all type of airports) shall be paid annually during the validity period of the airport certificate, depending on the type of the certificate held and on the traffic volume (if applicable). The fee amounts are specified in the table in paragraph (1) of this Article (column 2).

#### Article 44

- (The amounts of fees for processing an application for issuance of a safety/security approval)
- (1) The amount of fee for processing an application for issuance of a security approval and of a restriction, in relation to the requirements for use of a location for the purpose of building an airport, shall be 10% of the fee for the primary inspection for issuance of an aerodrome operator certificate.
- (2) The amount of fee for processing an application for issuance of a safety approval for installation or construction of safety-related technical systems, facilities, installations and devices shall be 0.4% of the investment value of the facilities, installations or devices in accordance with the relevant enclosed documentation, but not less than BAM 500.00.
- (3) The amount of fee for processing an application for issuance of a safety approval for the installation, construction, expansion and legalisation of facilities, installations and devices that may form potential obstacles to air navigation shall be:
  - a) for natural persons: BAM 300.00 per facility/location analysed as a potential obstacle,
  - b) for legal persons: BAM 700.00 per facility/location analysed as a potential obstacle.

#### PART VIII - GRANT OF EXEMPTIONS

Article 45

- (The amount of fee for processing an application for grant of exemption)
- The amount of fee for processing an application for grant of exemption from implementation of a regulation shall be BAM 2,000.
- (2) The fee referred to in paragraph (1) of this Article shall not apply to the procedure to grant exemption from implementation of the regulations for aircraft used in accordance with the provisions of Article 6 (2) of the Aviation Law of Bosnia and Herzegovina.

## PART IX – PLANNING, BOOKING, ALLOCATION AND EXPENDITURE OF FUNDS

#### Article 46

(Planning of funds)

The funds collected on the basis of this Decision shall be planned in accordance with the provisions of the Law on the financing of the institutions of BIH (Official Gazette of BIH 61/04 and 49/09).

#### Article 47

#### (Booking and allocation of funds)

The funds collected on the basis of this Decision shall be booked to the Special Purpose Programme "Charges pursuant to Article 13 (1) e) of the Aviation Law of BIH" in the amounts and in line with the economic categories as laid down in the Law on the budget of the institutions of

BIH and the international obligations of BIH, and shall be available in accordance with the inflow dynamics.

#### Article 48

(Expenditure of funds)

The funds referred to in the previous article shall be used to finance the following expenditures:

a) 50% for contracted and other special services,

- b) 30% for travel costs,
- c) 10% for fuel and transportation services,
- d) 10% for ongoing maintenance, power supply, telephone services, utilities and other services.

#### PART X – PAYMENT OF FEES

### Article 49

#### (Payment of fees)

- (1) The fees defined in this Decision shall be paid in BAM to the Bosnia and Herzegovina Directorate of Civil Aviation account with the UniCredit Bank d.d. Mostar, number 3389002208326551, while any payments from abroad shall be paid to an account with the Central Bank, in accordance with instructions given on submitted invoices.
- (2) The fees defined in this Decision shall be paid by an applicant when submitting an application, to the account referred to in paragraph (1) of this Article, with a mandatory reference to the Decision's article comprising the relevant fee.
- (3) The applicant shall submit proof of payment of the fee referred to in paragraph (1) of this Article, enclosed with the application.
- (4) Pursuant to the Law on Administrative Fees (Official Gazette of BIH 16/02. 19/02, 43/04, 8/06, 76/06, 76/07. 84/13 and 19/14), the Administrative Fee Tarrif and the amendments to the Order on the Payment Accounts for Administrative Fees, notwithstanding the fees defined in this Decision, the BHDCA shall charge fees for all records and actions in the administrative matters falling under the responsibility of the BHDCA, as well as for other subject matters and actions envisaged in the Tarrif.
- (5) Charging control shall be monitored by the BHDCA's Finance and Accounting Department, in cooperation with Heads of Sections and the Ministry of Finance and Treasury of BIH, and for any funds paid in error or for any overpayment, the Finance and Accounting Department shall refund the overpaid amount, upon a request by the payer and on the basis of a decision taken by the BHDCA.

#### PART XI – FINAL PROVISIONS

Article 50

#### (Final provisions)

- This Decision shall enter into force on the eighth day following its publication date in the Official Gazette of BIH.
- (2) The entry into force of this Decision shall repeal the Decision on the fees for the financing of the BHDCA pursuant to Article 13 (1) e) of the Aviation Law of Bosnia and Herzegovina (Official Gazette of BIH 02/12), the Decision amending the Decision on the fees for the financing of the BHDCA pursuant to Article 13 (1) e) of the Aviation Law of Bosnia and Herzegovina (Official Gazette of BIH 08/12) and the Corrigendum to the Decision on the fees for the financing of the BHDCA pursuant to Article 13 (1) e) of the Aviation Law of Bosnia and Herzegovina (Official Gazette of BIH 08/12) and the Corrigendum to the Decision on the fees for the financing of the BHDCA pursuant to Article 13 (1) e) of the Aviation Law of Bosnia and Herzegovina (Official Gazette of BIH 09/12).
